## PROFILE OF ROZANAH AB. RAHMAN

Rozanah Ab. Rahman is Professor of Law at the School of Business and Economics, Universiti Putra Malaysia. She graduated with Bachelor and Master Degrees in Law and obtained her Ph.D in Law from the International Islamic University, Malaysia. She also obtained her professional qualification as an Advocate and Solicitor of Malaya and as a Certified Professional Trainer from the Malaysian Institute of Management (MIM). Her areas of interest and specialisation are the Industrial Safety (OSH) Law, Employment Law and Business Law. Academically, she has published academic books, articles and writings in academic and professional journals, academic modules as well as presented academic papers in conferences and seminars, locally and internationally. She was also appointed as the Editors and Associate Editors on Editorial Board for academic journals, assessor for journal articles and manuscripts, as guest lecturer, invited speaker, subject matter expert and examiner for students' research and academic courses in other public and private universities, institutions and training companies.

She is internationally and locally recognized, including her appointment as the Visiting Associate Professor to the Faculty of Business Management, Tashkent-State-Technical-University, Tashkent, Uzbekistan, Visiting Fellow to the Alliance Manchester Business School (University of Manchester, United Kingdom), Lincoln International Business School (University of Lincoln, United Kingdom) and UWA Business School (University of Western Australia).
