### RESEARCH RELATED TO FIELD OF SPECIALISATION

My research contributions have been in five main areas:

#### (a) Social Security and Unemployment

The focus of my research here is to develop an unemployment insurance (UI) system for Malaysia. The output of this research has been implemented into a national policy in January 2018, and is known as the Employment Insurance System (EIS). The system aims to enhance workers' safety net. It is an integrated employment service, offering employment insurance, Public Employment Services (PES), and Labour Market Information (LMI) to the Malaysian workforce.

### (b) Labour Demand

My research on the labour demand has centered on two main issues: i) The dominant changes in labour demand that affect structural changes and trade; and ii) mismatches between labour demand and supply. I contributed 4 categories to Malaysia's mismatch index, namely education, occupation, skill, and location. My research also implemented Computable General Equilibrium (CGE) modelling to justify the impact of certain policies on job creation in critical sub-sectors, such as the green



economy. Both aspects of my work here have contributed significantly to policy debates and formulation, especially the 11th Malaysian Plan (EMP).

### (c) Multidimensional Poverty

The main contribution of my research is the introduction of a new measurement of poverty that goes beyond the monetary aspect. Multidimensional poverty involves the measurement of poverty with a set of direct and indirect methods, that is, monetary and non-monetary measures. Indicators used to measure such poverty are of variable domains of deprivations, ranging from financial wealth and lifestyle to housing and housing environment and basic necessities.

### (d) Minimum Wage

A further area of research which has also had an important policy-related impact is my work on the incidence of low pay. This study is the first to use data that matches information on employees and employers with that of their workplaces, allowing a more thorough examination of the correlates of low pay. The work itself was initially funded by the National Wages Consultative Council as part of their evaluation and monitoring activities.

### (e) Employment growth

Linked to my work on skills-related issues is a research that I carried out on the effects of R&D activities on employment growth. Using economics modelling, I have developed two systems to forecast the manpower requirement for professional workers and construction labour. The system for the former is called Manpower Economic and Development Systems (MEDIS) and the latter Construction Personnel Modelling Systems (COPMOS). This work also looked at the demand and supply of labour and at the impact of foreign labour. The results have been used by the government as a guideline to estimate future supply and requirement of local and foreign labour. Other contributions include an analysis of job creation and job destruction during employment growth.
